## NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES

**NOTE:** The winners of Veteran classes if otherwise undefeated, are eligible to compete for Best of Breed.

**Non-Regular Classes offered (Same classes for Bitches)**

Veteran Dog (7-under 10 yrs)

Veteran Dog (10-under 12 yrs)

Veteran Dog (12-under 14 yrs)

Veteran Dog (14+ yrs)

**Veteran Classes** - For dogs and bitches seven years of age and older. In accordance with Chapter 11, Section 8, veteran dogs and bitches may be spayed or neutered at specialty shows. All winners of Veteran Classes, if otherwise undefeated, are eligible to compete for Best of Breed. First place winners of the Veteran Dog and Veteran Bitch Classes will compete for Best Veteran Dog and Best Veteran Bitch after Best of Breed.

**Performance: (National only, Same classes for Bitches)**

Performance Dog

**Performance:** For dogs and bitches, 6 months of age and over, that have earned at least one title in any AKC Companion or Performance Event (Agility, Herding, Obedience, Rally, Scent Work or Tracking). Dogs entered in these classes must not have been neutered or spayed. By virtue of winning these classes, the dog and bitch are eligible to compete for Best of Breed provided they have not been defeated in any other class. Performance Dog and Performance Bitch.

**Sexually Altered: (National only, Same classes for Bitches)**

Sexually Altered Dog

**Sexually Altered Class:** For dogs and bitches, six months of age or over that have been neutered or spayed. The dog and bitch winning these classes are not eligible to compete for Best of Breed. Sexually altered Dog and Sexually Altered Bitch

**NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES (National Only)**

**NOTE:** *As the judges' decision in these classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won any of these classes.*

**STUD DOG CLASS** - For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the regular classes, or if a Champion of Record, in the Best of Breed Competition, but *MUST* be entered in the Stud Dog Class. The Get *MUST* be entered in one of the regular conformation classes or for Best of Breed Competition. No Stud Dog or his Get may be shown as a part of another unit. The Stud Dog shall be considered as one entry and requires one entry fee. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require disqualification or excusal under the Dog Show Rules, AKC Policy, or the standard for its breed.

**BROOD BITCH CLASS** - Same as for the Stud Dog Class except substitute "Brood Bitch" for "Stud Dog" and "Produce" for "Get."

*Chapter 11, Section 8: of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."*

**BRACE CLASS** — Each Brace shall be composed of two (2) Bearded Collie with at least one common owner, to be shown in the ring at the same time. The dogs comprising a brace must be named at the time of entry. The entry form for each dog entered as a part of a brace that is already entered in a regular conformation class or Best of Breed *MUST* be marked accordingly in the space for Additional Classes - "Brace Class." **Entrants must be entered in another class.**

**Junior Showmanship (National Only)**

**NOVICE CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

**OPEN CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present in the Novice class. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements, according to their records.

**MASTER CLASS:** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be

meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

**NOTICE:** Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

**NOTE:** SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

**Stewards of Children** - Anyone in violation of a restriction pursuant to AKC rules or policies, or the law can be asked to leave the grounds. If the person fails to leave, the local authorities will be contacted. In addition, if the club believes laws, restrictions or conditions of release are being violated by an individual's attendance or participation in AKC events, the local authorities will be contacted immediately as they have the authority of enforcement.

#### **4 - 6 Months Beginner Puppy (National Only)**

Dogs & Bitches will be judged together

##### **Entry Requirements:**

1. The Four to Six Month Puppy competition shall be for the Bearded Collie that are four months of age & over but under six months on the day of the competition.
2. AKC registration number or an AKC litter number will be required for entry.
3. All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.

This is a recorded event by the AKC for the Certificate of Merit and Puppy of Achievement certificates. #### **SWEEPSTAKES**

This Sweepstakes is open to all Bearded Collies who on the day of the show will be at least six (6) months of age and under 20 months of age. Dogs shown in Sweepstakes must also be entered in one of the regular classes. Champions of Record may be entered in Sweepstakes. Indicate "Sweepstakes" and Age Division on the regular entry form under "Additional Classes".

Division of Cash Prizes: Cash Prizes after 50% of entry fees in the Sweepstakes has been deducted for club expenses, the remaining 50% of entry fees will be divided as follows:

Classes with 4 or more entries: 1st-40% • 2nd-30% • 3rd-20% • 4th-10%

#### **VETERAN SWEEPSTAKES**

Veteran Sweepstakes is open to all Bearded Collies who on the day of the show will be at least seven (7) years of age or older. Veteran Sweepstakes will be judged prior to the Regular Classes. Indicate "Veteran Sweepstakes" and Age Division on the regular entry form under "Additional Classes". Spayed or neutered dogs are eligible.

Division of Cash Prizes: Cash Prizes after 50% of entry fees in the Sweepstakes has been deducted for club expenses, the remaining 50% of entry fees will be divided as follows:

Classes with 4 or more entries: 1st-40% • 2nd-30% • 3rd-20% • 4th-10%

Classes with 3 entries: 1st-50% • 2nd-30% • 3rd-20%

### OBEDIENCE AND RALLY

Include Jump Height on Entry Form for Classes Requiring Jumps. Judging will be in Ascending Height Order beginning at 4". "Dog" refers to either sex. Qualifying Score Required for All Awards in Regular and/or Optional Titling Classes A refund will be given to any exhibitor who has a bitch entered in the obedience trial or rally trial that comes into season after the close of entries. To receive a refund, the show secretary must be notified no later than one half hour prior to the start of the first class in each trial. RALLY TRIAL - Ring size will be at least 40' x 50'.

**Regular Classes:** Novice A, Novice B, Open A, Open B, Utility A, Utility B

**Preferred Titling Classes:** Preferred Novice, Preferred Open, Preferred Utility

**Optional Titling Classes:** Beginner Novice A, Beginner Novice B, Graduate Novice, Graduate Open, Versatility

**Non-Regular Classes:** Veteran, Novice Brace\*, Team Obedience\*

*Veterans Class:* The Veterans class will be for dogs that have an obedience title and are at least 7 years old on the date of the trial. The exercises will be performed and judged as in the Novice class. Dogs may be entered in another class or classes.

### RALLY TRIAL CLASSES

**Regular Classes:** Novice A / B, Intermediate, Advanced A / B, Excellent A / B, Master, Choice

**Non-Regular Class:** Pairs Novice\*

*Rally Pairs Class.* Rally Pairs class consists of competition by one handler working two dogs at one time through a rally course at a level selected and offered by the event-giving club. Scores will be based on a possible 200 points, with ties being broken by time.

**\*NOTE: Obedience Brace, Team Class & Rally Pairs:** Each team member must submit entry form and pay a fee, an alternate is allowed, as the fifth member would submit a form without a fee. If mailed separately, fill out a full entry form and attach a sheet with the registered names of the other team members or use form on next page..

### TRANSFER POLICY FOR THE SPECIALTY AND TRIALS

The Club will permit a transfer to the next level class in accordance with AKC regulations. The request for a Transfer must be made in writing and presented to the Show Secretary at least 30 minutes prior to the start of the specified event, show or trial. ### **BEST FROM THE REGULAR PUPPY CLASSES (Both Local & National)**

Best Puppy From The Regular Puppy Classes First place winners in Puppy Classes, 6 mos. and under 9 mos. and 9 mos. and under 12 mos., both sexes will compete together and will be judged after Best of Breed.

### **BEST FROM THE BRED BY EXHIBITOR CLASSES (Both Local & National)**

After Best of Breed, Selects and Awards of Merit are chosen, the winners of Bred By Exhibitor Dog and Bred By Exhibitor Bitch compete for Best Bred by Exhibitor. If Best of Winners is from the Bred by Exhibitor class, that entry is automatically Best Bred by Exhibitor.

### **BEST VETERAN DOG & BEST VETERAN BITCH (Both Local & National)**

- Up to four people and four dogs allowed in guest rooms. NOTE that four people plus dogs will be extremely tight. We recommend no more than two people and two dogs per room for your comfort.
- Dogs must be crated in guestrooms when owners are not in the room. Each guest is responsible for any damages. Please use the door hangtag provided at check-in when dogs are in the room. Please use the plastic under crates provided at check-in.
- There will be a \$75.00 non-refundable pet fee required for each guestroom.
- Please use provided sheets to cover the beds.
- The resort has many walking trails, but you may not use golf course cart paths for exercise. Stay off the golf course unless you are playing.
- Dogs must be kept on leash or crated around competition areas and elsewhere outside your room, except when showing in an obedience or agility ring. **NO off-leash play or walking. This is against hotel policy and violates our contract with the resort. It may be a safety hazard to your dog no matter how well-trained.**
- **You will be responsible for any damages or excessive cleaning required for your room and may face disciplinary action from the American Kennel Club and /or BCCA if such situations are not handled properly.** Cleaning supplies will be available should you need them.
- No dogs are permitted in the indoor restaurants or within the gated pool area. They are welcome on patios and in outdoor dining areas. Please observe and obey signs – some areas of the hotel grounds are off-limits to dogs. Please respect posted signs and staff directions regarding designated areas. NOTE: the dog walking areas behind the San Miguel and San Diego buildings are not well lit at night. We recommend using the areas in front of those buildings around the tennis and pickleball courts after dark. You will have a flashlight in your welcome bag that we suggest you take out with you at night.
- Clean up exercise areas and deposit in provided trash receptacles. Failure to do so may result in disciplinary action.
- Be vigilant and do not allow your dog to mark/urinate on walls, furniture, decor, etc. If you do have an accident, please find available clean-up supplies immediately.
